Horizon Europe (2021-2027) is the European Union's (EU's) key funding programme for research and innovation, with a budget of more than €95 billion. The programme is built around three main pillars – excellent science, global challenges and industrial competitiveness, and innovative Europe.

Five missions relating to climate change, cancer, oceans and water, carbon-neutral cities and soil health, also form an integral part of Horizon Europe.

Ireland enjoys a strong track record in European Framework Programmes, winning €1.2 billion in funding through Horizon 2020 (2014-2020).

Our National Support Network team for Horizon Europe works with Ireland's researchers, innovators and entrepreneurs to help them compete for and win funding to advance their research and innovation ambitions.

This team is made up of European advisors based in 10 Irish research and industry agencies including Enterprise Ireland, Irish Universities Association, Research Ireland, Health Research Board, Irish Research Council, Sustainable Energy Authority of Ireland, Department of Food, Agriculture and the Marine, Marine Institute, Environment Protection Agency and Department of Housing, Local Government and Heritage.
